- II. Discussion of Vestry Papers---How Not to Make Decisions from Episcopal Church Foundation
- III. Consent Agenda motion to approve from Gwen A. Seconded and passed by vestry
- IV. Vestry Covenant—Concerns addressed—recommending Safeguarding God's People guidelines, directly addressing the person involved. Sylvia made a motion to adopt Vestry Guideline Shawn seconded, and the matter was passed by the vestry present
